#### Corporate Sustainability Management in Japan and Korea

#### - Questionnaire Data -

With regard to the results of questionnaire survey quoted in the main text, we hereby present the results of responses from corporations.

As previously stated in the main text, data of Japanese corporations are cited from a questionnaire survey, "Research on Environmental Action of Corporations" conducted by Ministry of the Environment, Japan (MoEJ). Data of Korean corporations correspond to the survey results independently conducted by the authors and other co-researchers in the fall of 2002. Also for the better comparison with Japanese data, questions asked in Korean survey are based on those used in the MoEJ survey.

Of the 653 listed companies, manufacturing industry accounts for 69.8% (456), construction 7.4% (48), finance 6.0% (39), service 5.8% (38) and distribution industry 5.1% (33).

Regarding 98 companies who responded, manufacturing industry makes up a large percentage of 89.8% (83), construction 7.4% (6.0%) and distribution industry 5.1% (3). As for energy industries such as electricity and gas, two companies answered out of 9, while none of 39 financial institutions responded to the survey.
